The issues and priorities developed at the All WID Planning meeting were reviewed and amended.

B. Update Comprehensive Plan – report from Heather on progress to date on the Comprehensive Plan. Heather suggested that the Board concentrate on Table 2 which correlates goals with action plans. It should be reviewed and approved before we place it on the website as a draft plan. Brad suggested the board first make sure the draft does not include any messages that we don't agree with or want to make public. Then the board will work through the table priority by priority over the next meetings to fill in the gaps.

Heather suggested that once the plan was placed on the website it would be a living document that would be edited periodically: 1) based on board actions, 2) by staff as they become aware of information supporting board priorities, and 3) by consultants, as needed and determined by the board, to fill in more substantial gaps in the plan that would help facilitate the actions prioritized by the Board.

C. Annexations- no new areas under consideration.

III. Water Quality

- A. Monitoring Results lots of good samples but a couple spots remain of concern. WSDA has been quite actively monitoring.
- B. ZAP units one has been approved on the Fishtrap at the LCHS salmon site. The site at the PUD has not yet been calibrated to have confidence in the data. Hanna at Lummi is the contact for it.
- C. Exact Scientific source tracking technology Rep. Buys is trying to find some State money to support the \$150k need for developing samples to be used to calibrate the testing equipment.
- D. CAFO Permit a few are likely to apply for it.
- E. Portage Bay Partnership report debate over Experts continues. Some progress on the horizon
- F. Report on landowner contacts 6 landowners have been individually contacted in the last months.
- G. The Board heard positive feedback from the meeting with farmers sharing water quality information in February. The thought was to do something similar this fall.

IV. Water Supply – Henry reviewed current actions including:

A. Olympia Report — fate of ESSB 5239 — tied up in budget negotiations. The Tribes remain opposed and the Governor has promised he would not sign what they oppose. Several water attorneys are working together to develop a compromise that could gain support. AWB and Family Farmers are sending support letters for 5239.

- B. Whatcom Water Supply work group A list indicating the membership and goals of this organization was distributed. Issues being addressed and/or managed by this group include:
 - Lummi Infrastructure project
 - Birch Bay Water and Sewer Deep Aquifer project
 - Ground water Modeling
 - Drought Contingency Plan
 - WWSWG Action Plan
- C. Water Bank application This application is nearly ready to submit to the last review round. It would support work to review water rights and prepare several transfers making use of a water bank.

V. Drainage/Habitat

- A. Ditch maintenance Brad, Rod, and Terry met with Joel on potential maintenance projects.
- B. Culvert replacements the WDFW map of culverts and blockages was displayed. The idea of getting culverts fixed and banking the mitigation for future ditch maintenance projects was appealing. Lane Stremler indicated they could help with some culvert replacements. Brad wondered how much project money was left in the SWID budget. Henry felt there was between \$2-3k non-designated funds.
- C. 5-year programmatic permit S Lynden is having a 5 Year Plan developed for the entire WID. Frank Corey is preparing it for them. Sumas is interested as well but Frank is not available until later summer. It would be good to have a plan in place before we try to bank mitigation projects.

VI. Education/Communications

- A. Agricultural Protection strategy not discussed
- B. Commissioner Tour planned for June 13th with the agenda developed last fall.

VII. Ag Water Board

- A. Legal Bill Clarke continues to provide legal services and education support in Olympia on a monthly retainer.
- B. AESI instream flow report Chuck Lindsay's team has been hired to provide a clearer understanding of how to look at the In-Stream Flow settings on the River and tributaries. They should have a report prepared in the next two weeks.
- C. Strategy review the list of strategies and actions for the AWB that was generated at the Planning Workshop was distributed. Input should be provided to Andy, the AWB representative from the WID.
